Dear Secretary Burwell:

We are writing to applaud the Food and Drug Administration's recent approval of Probuphine, the first buprenorphine implant for the maintenance treatment of opioid dependence and to urge you to work with providers and manufacturers to make it affordable and accessible to everyone struggling with addiction.

As the scientific understanding of opioid addiction grows, we have a responsibility to treat it like the medical condition it is. Expanding the use and availability of medication-assisted treatment options like buprenorphine is key to combating this growing public health crisis. Medication-assisted treatment is cost-effective and has been proven to help patients recover from opioid use disorder and reduce fatal overdoses. The approval of this new implant could save lives and help those struggling with addiction without the risk that a dose is forgotten, stolen or abused.

All of our districts have been impacted by this epidemic. We again urge you to ensure that new treatments like the buprenorphine implant are affordable and accessible to everyone. We look forward to continuing to partner with you as we combat this epidemic.
